This is a commercial product whose exact ratio of components may vary slightly. Minor quantities of other non-hazardous ingredients are also possible.

**SECTION 4 FIRST AID MEASURES****General Information:**

**Skin Contact:** Gently brush away excess particles. Irritation is unlikely. However, if irritation does occur, flush with lukewarm, gently flowing water for 5 minutes or until chemical is removed.

**Eye Contact:** Quickly and gently brush particles from eyes. No effects expected. If irritation does occur, flush contaminated eye(s) with lukewarm, gently flowing water for 5 minutes or until the product is removed. **SECTION 6 ACCIDENTAL RELEASE MEASURES**

**Accidental release:** This product is sold in small packages, and the accidental release from one of these is not usually a cause for concern.
